**1. List various communication strategies used in your school to provide additional information to parents and to increase parent and family engagement in supporting classroom instruction.**

- The school will distribute a monthly newsletter to parents that is developed with participation of the parent-school organization, principal, staff and parent volunteers. It includes school news, a calendar of school activities, and parenting tips related to school achievement such as homework tips, organizational skills, and study skills. ( Lisa Pixley 471-3126)
- Parents can access their child’s grades using a PIN number they received at the beginning of the school year. Parents may use e-mail to communicate with members of the school staff. (Lisa Pixley 471-3126)
- Teachers will routinely contact parents on an individual basis to communicate about their child’s progress. (Mr. Mitchell 471-3126)

- The school will provide to parents reports/report cards every four weeks with information regarding their child's academic progress and upcoming classroom and school events. (Mr. Titsworth 471-3126)
- The school will send brochures home with students, post notices in school facilities and public buildings, and provide information for local newspapers and radio stations about parent workshops and meetings. (Mr. Titsworth 471-3126)
- The school will use the student handbook, school Web site, signage at the school entrance, and parent orientation meetings about the Schoolwide Title I Plan and how to get a copy upon request. (Mr. Titsworth 471-3126)

**2. List the proposed parent meeting, conferences and activities regularly throughout this year and the dates providing flexible meeting times that you have planned to increase parent and family engagement and build staff and parent capacity to engage in these types of effort**

**3. How will your school provide information to parents about volunteer opportunities?**

- The school will work with our elementary schools and Freshman Academy to help provide a smooth transition from one school to the next by raising parent awareness of procedures and related activities. The school will host special orientation programs for parents and students to help with the transition. Parents will have the opportunity to meet the new teachers at the end of the school year.

**6. How will your school provide resources for parents?**
