The Van Buren School District (VBSD) will involve parents in the development and review of the District Engagement Plan, and the School Improvement/Title I Schoolwide Plan by developing a district parent and family engagement committee to create a parent and family engagement plan and implement parent and family engagement opportunities and activities as determined by the committee and reflective of the needs of students and families.

The VBSD makes an effort to ensure adequate representation of parents and families of participating children in the process by inviting parents representing the district's student population to participate on the District Parent and Family Engagement Committee. We will try to make it convenient for parents by providing a meal. We will also have the principals at each site talk with parents who would best represent each school site about participating on the committee.

The District Engagement Coordinator will work with the School Improvement Committees to incorporate the Engagement Plan into the Schoolwide plan by:

- Establishing a parent and family engagement contact person at each school in the district.
- Forming a district parent and family engagement committee that meets once a semester to create a parent and family engagement plan and implement parent and family engagement opportunities and activities as

- determined by the committee and reflective of the needs of students and families in our district.
- Including a Parent and Family Engagement Contact Person from elementary and at least one from our secondary schools on the District Parent and Family Engagement Committee.

The Van Buren School District will make the Parent and Family Engagement Plan available to families and the community.

VBSD will file the district Parent and Family Engagement Plan with the Division of Elementary and Secondary Education by August 1.

VBSD will place a copy on the district website by August 1.

VBSD will place a parent-friendly summary of the Parent and Family Engagement Plan online and as a supplement to the student handbook (A paper copy will be provided to parents through school sites during fall parent/teacher conferences. A signature acknowledging the receipt of the district plan will be obtained.

The VBSD will reserve a minimum of 1% of the Title I, Part A allocation for parent and family engagement, with 90% going to Title I, Part A schools.

VBSD will conduct an annual review of the effectiveness of the parent and family engagement plan during the spring VBSD Parent and Family Engagement Committee Meeting.

VBSD will invite parents representing the district's student population to participate on the district parent and family engagement committee.

VBSD will incorporate the parent and family engagement plan into the Schoolwide Plan by using our principal meetings to review the plan quarterly and make sure we are incorporating the plan. VBSD will incorporate the parent and family engagement plan into the schoolwide plan by using Zoom meetings to discuss incorporation with the Parent and Family Engagement Coordinators across the district at least once a semester.

VBSD will submit to the state the comments from parents who deem the schoolwide plan unsatisfactory. Minutes from scheduled meetings will be recorded. Meetings are scheduled each quarter.

VBSD Parent and Family Engagement Objectives:

- The VBSD will maintain or increase attendance by 10% at Parent/Teacher Conferences from the fall conferences to spring conferences. Buildings will be asked to have sign-in sheets to track parent attendance. Once we have the data, we can track from year to year.
- The percentage of teachers providing Parents with ways to help their students at home will increase from approximately 60% to 95%. Principals will document how many teachers in their buildings are providing the "Help" section in their communication to parents and families. Copies will be collected from teachers.
- The VBSD will increase the number of community members serving on the District Parent and Family Engagement Committee by at least one.
